"I've just returned from maternity leave and I'm struggling with my work-life balance. How easy is it for treasurers to work flexibly or part-time?"



Returning to work after maternity leave can be difficult for many reasons, and struggling with your work-life balance is a common problem. Balancing a successful treasury career with responsibilities outside of work can be difficult at the best of times; and

the additional responsibilities of parenthood only add to the problems, with the need for some flexibility around working arrangements often being a necessity.

All parents with children under the age of 16 can request flexible working arrangements, as long as they have at least 26 weeks of service with their employer. Employers must seriously consider such a request, although they are within their rights to turn it down for sound business reasons. So if you are finding your hours a struggle, it is definitely worthwhile having a conversation with your manager.

Flexibility means different things to different people. It can mean coming in a bit later or leaving a little earlier, being able to work different hours during school holidays, working from home for part of the week or even working on a part-time basis. You may even find that a more informal arrangement, such as being able to work from home when your child is unwell, is all you need to negotiate with your employer.

With advances in technology allowing far greater access to your office from home, these are all very achievable. Perhaps the biggest obstacle to flexible working for treasurers is the fact that many treasury roles require the completion of a number of daily tasks, and this can make working less than five days per week a problem. Having a strong team around you, and being able to demonstrate that you will still be able to perform your duties, will definitely increase your options.

Your employer may not be able to offer you exactly what you are looking for, and there may be times when
