# Champions' night

THE WINNERS AND HIGHLY COMMENDED IN THE ACT'S DEALS OF THE YEAR AWARDS WERE HONOURED AT A DINNER LAST MONTH FOLLOWING ANOTHER CHALLENGING YEAR FOR EVERYONE INVOLVED IN THE CAPITAL MARKETS IN 2011.

Last month's celebration of the ACT's Deals of the Year Awards – now in its 14th year – recognised the achievements of corporate treasurers in successfully utilising the debt and equity markets on behalf of their companies in 2011.
