# Notes to Results

(AwardCMF)



## INTRODUCTION

This document will help explain your results for the Award in Cash Management Fundamentals (AwardCMF) assessment and the next steps available to you.

## THE TEST SPECIFICATION AND PASS MARK

The Test Specification for the AwardCMF assessment is:

Unit name	Amount of questions	Question Style
Section A	50	50 multiple choice questions (MCQs)
Section B	40	40 MCQs split between 8 mini scenarios, each with 5 questions attached.
<b>Total</b>	<b>90</b>	<b>100</b>

The pass mark for the AwardCMF assessment is 70%. For each question, you will be advised to select one or more answers from the options supplied.

## PROVISIONAL RESULT

At the end of your AwardCMF assessment, you will be issued with a provisional result indicating a Pass or Fail grade. This will be communicated five working days after the last exam date for that session. You will be contacted, via email, with your confirmed result.

## CONFIRMED RESULTS

Your confirmed result will be emailed to you. There are two forms of a confirmed result: an eCertificate or a Fail Notification. A description of both is given below.

## eCERTIFICATE

Should you achieve a pass in your AwardCMF exam, you will be issued with an eCertificate as your confirmed result notification. The certificate will be sent to you in a PDF format and is yours to print and keep.

The three pass grades achievable are:

Grade achieved	Grade boundary
Distinction	You have scored 90% or more
Merit	You have scored between 80% and 89%
Pass	You have scored between 70% and 79%

Please note that it is the policy of the ACT not to release the exact mark achieved.

## FAIL NOTIFICATIONS

Should you have failed the AwardCMF assessment, you will be issued with a Fail Notification. The table below sets out the grade boundaries within a fail notification

Grade achieved	Grade boundary
Fail	You have scored between 0% and 69%

Please note that it is the policy of the ACT not to release the exact mark achieved.
